Furthermore, my secretary positions in SSHP and SSEC have reinforced my ability to communicate information in a concise and useful manner. These roles will serve me well when collaborating with other APhA-ASP members to oversee and execute events at both the Midyear Regional Meeting (MRM) and APhA Annual Meeting. In my role as APhA-ASP Policy VP Chair for my chapter, I have gained firsthand experience with the policy proposal development process, hosting events for my chapter such as Policy and Pizza, in which I educated chapter members on the policy timeline of APhA-ASP and presented several policy proposals drafts for the chapter to provide feedback on. Furthermore, my involvement in a variety of professional pharmacy organizations has exposed me to many ideas and initiatives. For instance, in IPhO, I participated in the VIP Case competition, gaining greater knowledge of the clinical development process for new drugs. These experiences will help me when evaluating policy proposal ideas at MRM and the APhA Annual Meeting.

This ability will be important to have when helping to moderate the APhA-ASP Policy Proposal Forum during MRM.

As an APhA-ASP Regional Delegate, how will you extend the involvement of

student pharmacists in the APhA-ASP Policy Process and advocacy initiatives beyond chapter delegates and chapter policy vice presidents?

To extend student pharmacist involvement in the pharmacy process, I would

reach out to Chapter Policy VPs and Chapter Presidents about guest speaker events which would be aimed at explaining the policy process to local members. For such events, I would work with both the chapter and APhA-ASP Policy Standing Committee to connect the chapter with an available guest speaker. In addition, I would like to hold webinars in which any APhA-ASP members can participate in guided brainstorming forums for policy resolution proposals, as well as develop webinar initiatives that simulate the policy process from MRM to House of Delegates.
