I will use my success to guide the region's Policy VPs to host their own policy events and provide them with the necessary tools to simplify the process, thereby empowering them to drive the involvement of student pharmacists in policy and advocacy initiatives. Additionally, effective communication is crucial to ensure the success of chapters, and I want to improve the transmission of communication between national and chapter leadership. This is particularly important during times of change, such as following the significant adjustments in the structure of the Midyear Regional Meeting (MRM). To prevent confusion, I will work proactively with national leadership to ensure Policy VPs receive the information they need to engage with the APhA-ASP Policy Process preceding the annual meeting and next year's MRM. Lastly, I will work to connect chapter Policy VPs with their counterparts in other chapters and explore opportunities for shared initiatives.
